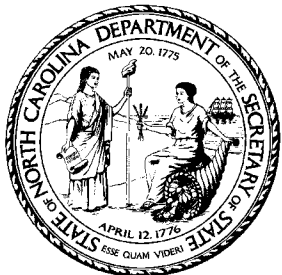



Purpose of Global Center for Siddha Medicine and Research

To conduct research and document the basic principles and methods of prevention of diseases, diagnostic procedures, curative methods, palliative care, rehabilitative procedures and other exclusiveness of Siddha system of medicine which is native to the state of Tamil Nadu , India so as to make it available to all.

To analyze and document, collect ancient Siddha palm manuscripts or written literature or oral tradition and to translate in many International languages

Actively participate in supporting and promoting traditional SIDDHA Medicine and traditional foods of Tamil Nadu a state in India, which is based on the concept ` Food is medicine'.

Consistently promote the synthesis of the values of the traditional systems of medicine and the systematic approach of the modern biomedical systems towards achieving synergetic integration of all systems as appropriate.

Advocate and assist in the creation of a formal institutional framework to ensure consistency in the quality of drugs produced under the traditional systems of medicines and to ensure their efficacy.

Vision and Mission of Global Center for Siddha Medicine and Research

** Establish links with national and international non-governmental organization and relevant government organizations in the pursuit of the goals and objectives of the Organization.*

** Work with medical colleges and other professional training institutions to develop skills development programs that will encourage the absorption of the positive aspects of health promotion and disease prevention from the different systems of medicines. Also propagate these skills development programs through all channels of communication including the electronic media by the creation of virtual classrooms.*

** Incorporate evidence based traditional Siddha drugs or therapies with Complementary and Alternative Medicines therapies in order to integrate with biomedicine to promote health, and to treat and cure diseases*

** Help in learning the Siddha therapies to any health professionals in USA and also to create an opportunity for US Medial students to involve in learning & research on Siddha therapies by exchange programs.*

** Establish a Siddha Institute in major medical institutions nationally and internationally. Spreading the knowledge of Siddha through presentation of papers in National and International Conferences, via television shows, discussions and book publications .To financially support the research programs in Siddha medicine and Publishing Siddha palm manuscripts into books in multiple languages*

** To Promote the concept and active practice of strengthening families that will lead to strong communities.*

Distribution of Assets

Upon the dissolution of the center, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, scientific or literary purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Code as the Board of Directors shall determine, or to federal, state, or local governments to be used exclusively for public purposes. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, such as the court shall determine, which are organized and operated exclusively for such purposes, or to such governments for such purposes.
